Pursuant to the provision of §617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation.

1. **Article IV, Section 3** is hereby amended to replace **YOUNG ESTATES, LLC** to show the proper ownership name and shall read as follows:

"Developer" shall mean **JOE N. FINCHER and DONALD G. YOUNG, JR.**, and its successors in interest or assigns of all or, at the election of the "Developer", substantially all of its interests in the Subject Property.

2. The date of adoption of the amendment was: **May 26, 2006.**
