ARTICLES OF INCORPORATION Of PAUSE, STOP and THINK, INC.

We the undersigned incorporators, in order to form a corporate entity pursuant to Chapter 617.0202, Florida Statues (F.S.), set forth and do hereby incorporate ourselves as a body corporate, and adopt the following articles of incorporation.

ARTICLE I NAME

The name of this corporation shall be: PAUSE, Stop and Think, Inc.

ARTICLE II PRINCIPLE OFFICE

ARTICLE III PURPOSE

Specifically this is a not for profit organization advocating the educational philosophy of abstinence until marriage.

As within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall educate young men and women between the ages of ten (10) and eighteen (18)

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

With the life changing message of abstinence until marriage. This positive message is reenforced through the performing arts, oration, personal life experience and State provided curriculum, pamphlets and other educational materials.

All funds, whether income or principal, and whether acquired by gift, contribution or otherwise, shall be devoted to said purpose.

ARTICLE IV MANNER OF ELECTIONS
