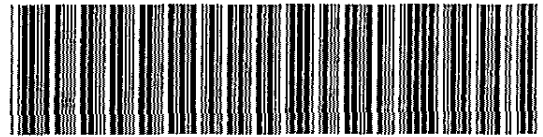



- TWO:** This Corporation is a nonprofit public benefit corporation and is not organized for private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, Charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Community Radio Programs for educational purposes and daily news, Literacy, Counseling, Tutoring, Substance Abuse Awareness and Prevention. Community Magazines, Haitian Business Directory Pages, and other programs on an as needed basis.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.


