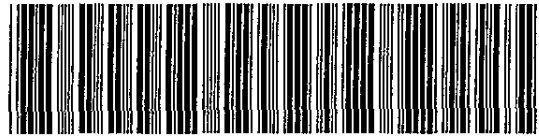

## Article I      Name

The name of the corporation shall be:      **Spiritual Reflections, Inc**

## Article II      Principal Office

The principal place of business shall be **525 S. Cleveland Street, Quincy, Florida**. The mailing address of the corporation shall be **525 S. Cleveland Street, Quincy, Florida 32351**.

## Article III      Purpose

The specific purposes for which the corporation is organized are as follows:

1. To be a non-profit corporation prescribed by Section 501(c)(3) and subsequent amendments, of the Internal Revenue Code, United States of America.
