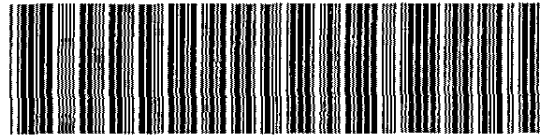

**ARTICLES OF INCORPORATION
OF

To form a not for profit corporation in compliance with Chapter 617, Florida Statutes, the following Articles of Incorporation were adopted by the undersigned and are being submitted for filing:

ARTICLE I: NAME

The name of the corporation is FOCUS Outreach Ministries, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address follow:

ARTICLE III: PURPOSE

FOCUS (Fellowship Of Christians United Spiritually) Outreach Ministries, Inc. offers:

teens alternatives to drugs, alcohol, and immorality,
teens positive and powerful ways to deal with peer pressure,
Biblical training in clear and understandable terms,
counseling to those in need, and
community service as opportunities are presented.

This corporation is organized exclusively for educational purposes permitted under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE IV: MANNER OF ELECTION

The Incorporator shall appoint the initial seven Directors: two will serve for one year, two for two years and the three for three years. The initial Directors will develop bylaws, which will delineate selection of subsequent Directors and Officers.

ARTICLE VIII: ORGANIZATIONAL TEST

FOCUS Outreach Ministries Inc. is organized exclusively for religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986.

No part of the net earnings of FOCUS Outreach Ministries Inc. shall inure to the benefit of, or be distributable to, its members, trustees, directors, or other private persons, except that FOCUS Outreach Ministries Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions on furtherance of section 501(c)(3) purposes.

No substantial part of the activities of FOCUS Outreach Ministries Inc. shall be the carrying on of propaganda or otherwise attempting to influence legislation, and FOCUS Outreach Ministries Inc. shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, FOCUS Outreach Ministries Inc. shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986.

Upon dissolution of FOCUS Outreach Ministries Inc. assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the internal Revenue Code or distributed to Federal, State, or Local Government for a public purpose.

However, if the named recipient is not then in existence or is no longer a qualified distribute, or is unwilling or unable to accept distribution, then the assets of FOCUS Outreach Ministries Inc. shall be distributed to a fund, foundation, or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code.


