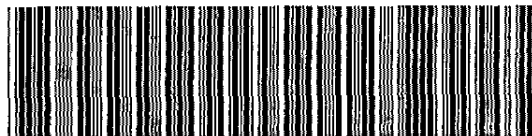

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I NAME

The name of this corporation is North Florida Emergency Services, Inc..

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.

ARTICLE III PURPOSE

This Not-for-Profit corporation is organized for the purpose of transacting any or all lawful business including acquisition of supplies and services for emergency needs for hospitals and other social programs and organizations in the North Florida community.

ARTICLE IV PRINCIPAL OFFICE

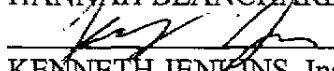
ARTICLE XII - AMENDMENTS

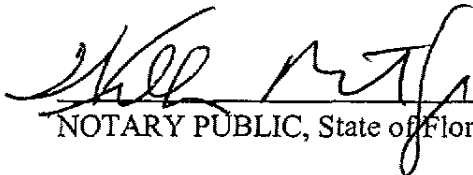
