ARTICLES OF INCORPORATION OF GONZALEZ UNITED METHODIST CHURCH, INC.

We, the undersigned desiring to form a corporation not-for-profit for charitable purposes authorized under Chapter 617, Florida Statutes, do hereby certify as follows:

ARTICLE I NAME AND LOCATION

Gonzalez United Methodist Church, Inc., 2026 Pauline Street, Pensacola, Florida 32533

ARTICLE II PURPOSES OF THE CORPORATION

The purposes for which the Corporation is formed, and the business and the objects to be carried on and promoted by it are as follows:

- 1. To be a worshiping fellowship, experiencing an awareness of God, recognizing His person and responding in obedience to His leadership.
- 2. To share the Gospel with as many people as possible in our church, community, and throughout the world.
- 3. To experience an increasingly meaningful fellowship with God and fellow believers.
- 4. To help people experience a growing knowledge of God and man.
- 5. To be a church which administers unselfishly to persons in the community and world in Jesus' name.
- 6. To be a church whose purpose is to be Christlike in our daily living by emphasizing total commitment of life, personality of life, personality and possessions to the Lordship of Christ.

ARTICLE III POLICY, RELATIONSHIP AND CHURCH MEMBERSHIP

All authority relating to the government of this church and its activities shall be in accordance with the Discipline of the United Methodist Church as the same presently exists or as it may be amended or modified from time to time.

The United Methodist Church, Inc., a fellowship of believers, is a part of the Church Universal. Therefore, all persons without regard to race, color, national origin, or economic condition, shall be eligible to attend its worship services, to participate in its programs, and, when they take the appropriate vows, to be admitted into its membership. The membership of the Gonzalez United Methodist Church, Inc., shall include all baptized persons who have come into membership by confession of faith or transfer and whose names have not been removed from the membership rolls by

reason of death, transfer, withdrawal, or removal for cause. Such members shall comprise the Church Conference as defined in the Discipline of the United Methodist Church.

ARTICLE IV TERM AND EXISTENCE

The term of existence of this corporation shall be perpetual.

The Corporation is irrevocably dedicated to, and operated exclusively for, nonprofit purposes, and no part of the income or assets of the Corporation shall be distributed to, nor inure to, the benefit of any members, director, officer, trustee, or employee of the Corporation, contributor or private individual. In the event of dissolution of the Corporation, the assets shall be distributed in the accordance with the terms of the United Methodist Church, provided that in any event such

distribution shall be to an organization qualified for exemption under Section 501(c)(3) of the Internal Revenue Code and an organization described in Section 170(b)(1)(A) of said Code.
