AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

GONZALEZ UNITED METHODIST CHURCH, INC. A FLORIDA NONPROFIT CORPORATION

Pursuant to Sections 617.1002, 617.1006 and 617.1007 of the Florida Statues, the Florida Nov For Profit Corporation Act, the Articles of Incorporation of the Gonzalez United Methodist Church, Inc. a not-for-profit corporation organized and existing under the laws of the State of Florida are amended and restated as follows:

ARTICLE I. NAME AND LOCATION

Effective May 7, 2023, the name of this corporation is Gonzalez Methodist Church, Inc. The address in 2026 Pauline Street, Cantonment, Florida, 32533.

ARTICLE II. PURPOSES OF THE CORPORATION

The purposes of the Corporation, and the business and the objects to be carried on and promoted by it are as follows:

- 1. To be a worshipping fellowship, experiencing an awareness of God, recognizing His person and responding in obedience to His leadership.
- 2. To share the Gospel with as many people as possible in our church, community and throughout the world.
- 3. To experience an increasingly meaningful fellowship with God and fellow believers.
- 4. To help people experience a growing knowledge of God and man.
- 5. To be a church which administers unselfishly to persons in the community and world in Jesus' name.
- To be a church whose purpose is to be Christlike in our daily living by emphasizing total commitment of life, personality of life, personality and possessions to the Lordship of Christ.

ARTICLE III. <u>POLICY, RELATIONSHIP AND CHURCH MEMBERSHIP</u>

All authority relating to the governance of this church and its activities shall be in accordance with *The Transitional* Book of Doctrines and Discipline of the Global Methodist Church* (herein referenced as *Doctrines and Discipline*) as the same presently exists or as it may be amended or modified from time to time.

The Global Methodist Church, Inc., a fellowship of believers, is a part of the Church Universal. Therefore, all persons without regard to race, color, national origin, or economic condition, shall be eligible to attend its worship services, to participate in its programs, and, when they take the appropriate vows, to be admitted into its membership. The membership of the Gonzalez Methodist Church, Inc., shall include all baptized persons who have come into membership by confession of faith or transfer and whose names have not been removed from the membership rolls by reason of death, transfer, withdrawal, or removal for cause. Such members shall comprise the Church Conference as defined in the *Doctrines and Discipline*.

ARTICLE IV TERM AND EXISTENCE

The term of existence of this corporation shall be perpetual.

The Treasurer of the Corporation shall be the Church Treasurer and be elected as provided by the *Doctrines and Discipline*.

ARTICLE VIII THE BOARD OF TRUSTEES

The Board of Trustees shall consist of at least five persons to be elected for three year terms as provided by the *Doctrines and Discipline*. Vacancies of any office of trustee shall be filled as provided by the *Doctrines and Discipline*.

ARTICLE IX BYLAWS

The by-laws of the Corporation shall be the *Doctrines and Discipline* as the same presently exists or as the same may be modified or amended from time to time provided however that the members of this Corporation or the Board of Trustees subject to approval by said members may provide additional by-laws and amendments thereto which are required by and not in conflict with the provisions of these articles of incorporation or with the *Doctrines and Discipline*.

Gonzalez Methodist Church recognizes that its corporate powers are subject to the *Doctrines and Discipline* and that its corporate powers cannot exceed those given by the *Doctrines and Discipline*.

ARTICLE X <u>AMENDMENTS TO ARTICLES OF INC</u>ORPORATION

These Articles of Incorporation may be amended by a majority vote of the Board of Trustees.

ARTICLE XI DISSOLUTION

This Corporation may be dissolved or liquidated by majority vote of the Charge Conference as provided in the *Doctrines and Discipline*.

The Corporation is irrevocably dedicated to, and operated exclusively for, nonprofit purposes, and no part of the income or assets of the Corporation shall be distributed to, nor inure to, the benefit of any members, director, officer, trustee, or employee of the Corporation, contributor or private individual. In the event of dissolution of the Corporation or the Corporation is abandoned, discontinued, or ceases to exist as a legal entity, the corporate property shall be distributed in the accordance with the terms of the *Doctrines and Discipline*, provided that in any event such distribution shall be to an organization qualified for exemption under Section 501(c)(3) of the Internal I. Revenue Code and an organization described in Section 170(b)(1)(A) of said Code.
