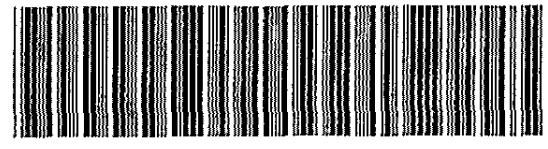

ARTICLES OF INCORPORATION OF  
GABRIELA MONTERROSO MINISTRIES, Inc.  
Nonprofit Corporation

We, the undersigned, acting as incorporators of a Corporation under Florida Non Profit Act, adopt the following articles Incorporation for such Corporation:

ARTICLE I: NAME

The name of this Nonprofit Corporation is: GABRIELA MONTERROSO MINISTRIES, Inc.. The principal address is 9700 SW 106<sup>th</sup> CT, Miami, FL 33176.

ARTICLE II: EFFECTIVE DATE

The effective date will be January 3<sup>rd</sup>, 2005.

ARTICLE III: REGISTERED AGENT AND OFFICE

The registered Agent will be: Rev. Mercedes del Valle Herrero. The initial registered office is located at 3300 Pembroke Rd #335- Pembroke Park, FL 33023.

ARTICLE IV: PURPOSE:

The purpose of this Corporation shall be the propagation and dissemination of the Gospel of Jesus Christ, through the preaching, teaching, and living of the full gospel message as outlined in the Articles of Faith of GABRIELA MONTERROSO MINISTRIES, Inc.. To accomplish such purposes the corporation may, among other means, establish Christians schools and colleges, home and foreign mission outreaches, hold evangelistic Crusades, open and hold Houses of Prevention for drug addicted or Homeless under A.M.A.R. ( Asociacion Movimiento Antidrogas de Rescate) and ultimately be engaged in all types of religious, educational and charitable activities worldwide including evangelism through electronic broadcasting, Internet, AM and FM radio, telecasting, cable and satellite television, and any other related projects for the carrying out of these ministries.

ARTICLE V: RIGHTS

It shall have the right to possess, buy , mortgage, sell, lease, barter and exchange real and personal property, to borrow money, collect funds, receive gifts and legacies as it may judge necessary for the attainment of these purposes.

This corporation is organized and operated exclusively for religious purposes, no part of the net earnings shall inure to the benefit of any private individual. No substantial part of the activities shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, the participation in, intervention in the publication or distribution of statements of any political campaign on behalf of any candidate for public office.

#### ARTICLE VI: BOARD OF DIRECTORS:

The following persons were chosen to be the initial Board of Directors.

**Secretary:** Rev. Mercedes del Valle Herrero – 3300 Pembroke Rd #335- Pembroke Park, FL 33023

**Treasurer:** Margarita Cabrera- 5755 W Flagler St- Suite 212- Miami, FL 33144

#### ARTICLE VII: APPOINTMENT OF DIRECTORS

The method of election of Directors is as stated in the bylaws of GABRIELA MONTERROSO MINISTRIES, Inc.

#### ARTICLE VIII: MANAGEMENT OF AFFAIRS

The management of the affairs of the Corporation is vested in the President (Chairman of the Board) and the Board of Directors. The corporation shall be governed by the provisions contained in its Constitution and Bylaws. The President, until his voluntary resignation or death is Rev. Robin R. Monterroso.

#### ARTICLE IX: MEETINGS

The Annual meeting of the corporation shall be held as stated in the Constitution and Bylaws.

#### ARTICLE X: PROPERTY.

Section 1. Documents relating to the conveying or encumbering real estate shall be signed by the President and other Board member as the Secretary.

Section 2: all property of this corporation should be recorded in the name of the corporation. In the event of a defection of any member of this Corporation from its Articles of Faith, or from affiliation with GABRIELA MONTERROSO MINISTRIES, Inc the title of all corporation property, real or personal, shall remain with those members abiding by such Articles of faith and retaining affiliation with GABRIELA MONTERROSO MINISTRIES, Inc..

#### ARTICLE XI: DURATION

The period of duration of this corporation is perpetual

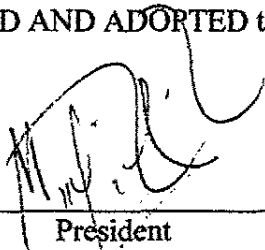
## ARTICLE XII: DISSOLUTION

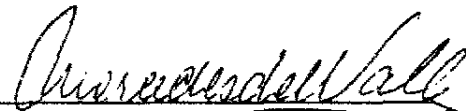
