

# ARTICLE I. NAME

# ARTICLE III. PURPOSE

## ARTICLE VIII. PROHIBITED ACTIVITES

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Articles III these Articles of Incorporation.

No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Not withstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code or corresponding provisions of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal revenue Code or the corresponding provision of any future federal tax code.

# ARTICLE IX. DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 © (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to federal government, or to a state or local government, for exclusive public purposes. Any such assets not so disposed of shall be disposed by a court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

# ARTICLE X. AMENDMENTS

The corporation reserves the right to amend, propose, adopt, alter, change or repeal any provision contained in the Articles of Incorporation and the By-laws by a vote of two-thirds of the active membership of the corporation present at any regular meeting of the corporation or at any special meeting duly called for the purpose, and all rights conferred on members of this corporation are granted subject to this reservation.
