Pursuant to the provisions of Fla. Stat. § 607.1006, this Corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation before amendment: Time for Freedom Ministries, Inc.

2. The name of the corporation after amendment: Re-entry Centers of America, Inc.

3. The text of each amendment as adopted is as follows:

A new article, Article XIV, is added, which states as follows:

Article XIV

Re-entry Centers of America, Inc. is a wholly-owned subsidiary of Time for Freedom Holding Company (a not-for-profit corporation).

4. If the amendment provides for an exchange, reclassification, or cancellation of issued shares, provisions for implementing the amendment, if not contained in the text of the amendment itself, are as follows: None.

5. The date of adoption of each amendment was: February 12, 2007.

6. Each amendment was adopted by: The incorporator. Shareholder action was not required.

7. These amendments will be effective upon filing.

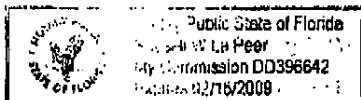
