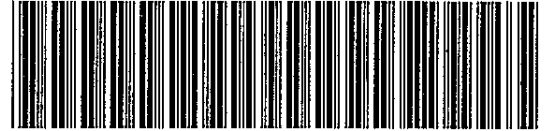

CERTIFICATE OF INCORPORATION OF:
HOPE HAITIAN COMMUNITY CENTER OF JACKSONVILLE, INC.

PURSUANT TO SECTION 617.1503(1), Florida Statutes.

The undersigned, natural persons of the age of eighteen or over, desiring to form a corporation pursuant to the provision of the Not-for-Profit corporation law, do hereby certify:

ARTICLE I **NAME**

The Name of the corporation shall be: **HOPE HAITIAN COMMUNITY CENTER OF JACKSONVILLE, INC.**

ARTICLES II **PRINCIPAL OFFICE**

The principal place of business of this corporation shall be in the State of Florida, city of Jacksonville. The physical address will be 1398 Menna Street Jacksonville Fl.32205 in Duval County.

ARTICLE III **PURPOSES**

The general nature and purpose for which the corporation is organized is: religious, charitable, educational and social, providing relief for distressed and underprivileged immigrants, primarily for recent, new-comers Haitian and their families.

In furtherance of the charitable and educational purposes, the corporation shall, provided assistance and referral services to recent immigrants to successfully function in their new environment. Programs shall include instruction and vocational skills in native and foreign languages, conduct activities to raise awareness among the Haitian-American community at large, and other communities about the difficulties of Haitian immigrants in adjusting to their new surroundings, encourage the communities to assist and support such category. Conduct any and all lawful activities to support newly arrived Haitian immigrants. Conduct any and all lawful activities, which may be useful in accomplishing the foregoing purpose.

ARTICLE IV **MANNER OF ELECTION**

The Incorporator and the Registered Agent appoint the Initial Board of Directors upon registration of the said corporation for a short period from six (6) months not to exceeding one year. Thereafter the appointed initial provisional Board of Trustees will meet and proceed to election of the first elected Board. Such election will be held in secret ballot among the remaining officers of the board of trustees as stated in the by-laws. Article IV, Paragraph 3.1)

ARTICLE V

The affairs of the corporation are to be managed by the following officers: An Executive Director, a Deputy Director, an Administrator, the Project Directors and the Program Directors





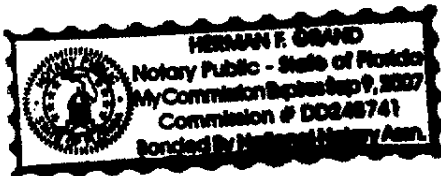
