

WE THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming incorporated pursuant to Chapter 617.0202 Florida Statutes as amended from time to time under the Laws of the State of Florida, applicable to corporations not for profit under the following proposed Charter.

ARTICLE I

The name of this corporation is GREATER KING DAVID INTERNATIONAL CHURCH, INC., OF ST. PETERSBURG, FLORIDA hereinafter referred to as "The Corporation". The existence of the Corporation will be perpetual.
