ARTICLE VII: New Article VII (Board of Directors) Replaces previous Article VII:

The affairs of the Association shall be managed by a Board of five (5), but not less than three (3), directors. The number of directors may be changed by amendment of the by-laws of the Association.

ARTICLE VIII: New Article VIII (Officers) Replaces previous Article VIII:

The officers of the Association shall be a President, two (2) Vice-Presidents who shall at all times be members of the Board of Directors, a Secretary, a Treasurer, and such other officers as the Board of Directors may from time to time by resolution create. The officers shall be elected annually by the Board of Directors and removed in accordance with the by-laws of the Association.

The amendments were adopted by members and the number of votes cast for the amendment was sufficient for approval.
