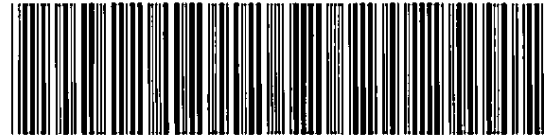

ARTICLES OF INCORPORATION  
OF  
MINISTERIO CASA DE ORACION

The undersigned acting as Incorporators of a NON PROFIT CORPORATION pursuant to charter 617, Florida Statutes, adpts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the corporation is: MINISTERIO CASA DE ORACION INC (House of Praying Ministry Inc) and the initial address of the corporation is: 12600 NW 4th Ave., Miami, Fl. 33168

ARTICLE II

The period of the duration of this corporation is PERPETUAL unless dissolved according to law. Corporate shall commence upon January 1st. 1984 (for accounting purpose only). Upon dissolution of the corporation, the Board of Director shall after paying or making provision for the payment of all of the liabilities of the corporation dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner or to such organization or organizations organized and operated exclusively for charitable, educational and religious purpose as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of the Court of Common Pleas of the County in which the principal office of the corporation is then located exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

ARTICLE III

The purpose or purposes for which the corporate is organized exclusively for charitable, religious and educational including for such purposes, the making of distributions to organization that qualify as exemp organization under section 501(c)(3) of the Internal Revenue Code of 1954. Its purpose especifically is to teach the Jesu's word; to help the poor and to coodinate with other organization the religious cooperation.

ARTICLE IV

The qualifications for member and the manner of their admission are: a) public committment and decision to accept Jesus Christ as personal savior and Lord; b) as aggregates from other congregations who wish to become affiliated with said organization. No other qualifications or admission prerequisite is required.

#### ARTICLE V

The street address and city of the initial registered office of the Corporation is 12600 NW 4 Ave. Miami, Florida and the name of its initial registered agent at such address is Carlos de Jesus.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision for these articles the corporation shall not carry on other activities not permitted to be carried on (a) by the corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

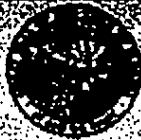
