## ARTICLE I

The name of the ministry is: Fresh Start Temple Incorporated

#### ARTICLE II

### ARTICLE III

The purpose for which the ministry is organized is:

Said organization is organized to operate exclusively for charitable, religious, educational, scientific purposes and distinct ecclesiastical purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and such purposes shall include the following:
