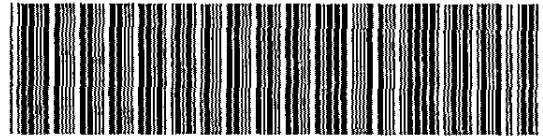



ARTICLE I

The name of the ministry is: Fresh Start Temple Incorporated

ARTICLE II

The principal place of business and mailing address for this ministry corporation is:

ARTICLE III

The purpose for which the ministry is organized is:

THIS ~~Said organization is organized to operate exclusively for charitable, religious, educational, scientific purposes and distinct ecclesiastical purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and such purposes shall include the following: *~~

(a) Religious Organization

(b) To conduct a local Church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God.

ARTICLE IV

The business and property ministry shall be managed by a Board of not less than, although not limited to three (3) Directors; (Trustees). The present Directors now duly constituted and elected shall constitute the board of Directors and they shall hold their offices permanently and so far as may be until other or further election. The Board of Directors is elected as stated in the articles.

In the event of the inability of any Director to act, or in the event of the death of any Trustee, the remaining Trustees shall elect another Trustee, or Trustees, to fill the vacancy or vacancies, thus created. Each Trustee shall be a member in good standing of the Ministry. A new trustee shall be elected by a majority vote of the total Trustees, excluding the Trustee whose position is being filled by vote.
