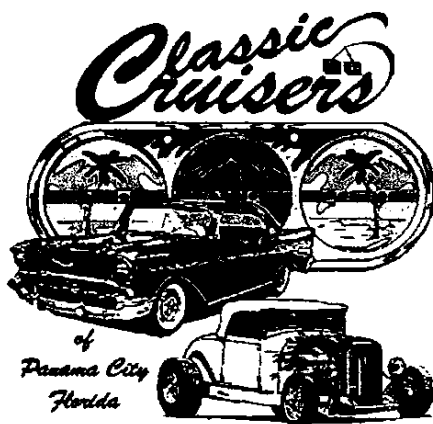
I was very upset when I was informed that the corporation was dissolved because I was sure I had done all that I should have and was unaware of any wrong doing.
