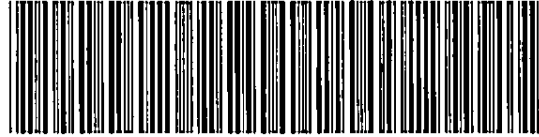

**ARTICLE III**


