Articles of Incorporation  
of  
Bob Heier Ministries, Inc.

The undersigned, acting as the incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article 1

The name of the corporation is Bob Heier Ministries, Inc.

Article 2

The principle place of business of this corporation is 802 Desoto Avenue, Lehigh Acres, Florida 33936 (Lee County).

Article 3

The corporation is organized as a not for profit organization exclusively for religious and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provisions of any future United States Internal Revenue law), including, but not limited to, for such purposes, conducting religious worship services, including the evangelizing of the unsaved by the proclaiming of the gospel of the Lord Jesus Christ, the educating of believers in a manner consistent with the requirements of Holy Scripture, maintaining missionary activities in the United States and foreign countries, and any other lawful purpose or purposes not for receiving profit and not specifically prohibited to corporations under other laws of the State of Florida.

Article 4

The corporation shall not have a formal membership and shall be governed exclusively by the Board of Directors. The method of election of directors shall be stated in the By-laws of the corporation. The corporation shall have a minimum of three directors.

Article 5

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its directors, officers, employees or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered to it and to make payments and distributions in furthering the purposes set forth herein.

Article 6

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organizations organized and operated exclusively for charitable, religious, or educational purposes as shall at the time

qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.

#### Article 7

The street address of the initial registered office of the corporation is 802 Desoto Avenue, Lehigh Acres, Florida 33936, and the name of the initial registered agent of the corporation at the initial registered office is Robert Heier.

#### Article 8

#### Article 9

The name of the incorporator of the corporation is Robert Heier and the address of the incorporator is 802 Desoto Avenue, Lehigh Acres, Florida 33936.

#### Article 10

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

#### Article 11

The period of duration of the corporation is perpetual unless dissolved according to law.
