ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is **City Covenant Church, Inc. – The city of the LORD**. This is going to be a church that will seek to minister to people of different ethnic backgrounds.

ARTICLE II

ARTICLE III

This corporation is organized for religious purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986. It is a non-profit religious entity.
