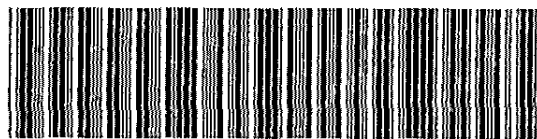



### NON FOR PROFIT ARTICLES OF INCORPORATION

- Article I: The name of the Corporation is HIV-Hepatitis Research Group Inc. and will be Incorporated in the State of Florida.
- Article II: The place of business and mailing address of the Corporation is: 12550 Biscayne Boulevard, Suite 404, North Miami, Florida 33181.
- Article III: The purposes for which the Corporation is organized is to bring awareness to individuals infected with (Human Immunodeficiency Virus, that is the Virus that causes AIDS, Acquired Immune Deficiency Syndrome) of a large percent of co infección with HIV (Hepatitis C Virus) and the need to screen these patients to treat them to avoid side effects that will cost patients lives in about 25% of them.
- Article IV: The directors are being elected based on direct experience with both diseases, and knowledge of the need of the population in these matters.
- Article V: The Directors are elected initially for a period of three (3) years, and according to the by-laws to be a Director, the individual had to be involved directly or indirectly in the care of HIV and/or Hepatitis.




