## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BELIEVER'S LIFE OF VICTORY MINISTRIES INC.

- 2. Notwithstanding any other provision of these articles, the corporation/ organization shall not earry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation/organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
- 3. Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the Federal government or to a state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.

The Board of Directors has adopted a resolution setting forth this amendment of the Articles of Incorporation.
