November 19, 2006

A special meeting of the Vestry of Christ's Anglican Church was called to consider a request to change banking institutions. The meeting was held following the regularly scheduled church service on December 19, 2006. The sitting vestry on that date consisted of the following with those whose names are preceded by an asterisk (*) being present.

The meeting was called to order by Ila Klueh in the absence of the Senior Warden. A motion was made by Irene Gonitzke to change the Church's banking institution from SunState Credit Union, Alachua, to Bank of America, High Springs. John Ehnat Seconded the motion.

During the discussion it was pointed out that the location of the Credit union makes it difficult, time consuming, and expensive for the treasurer to make the weekly deposits. Because Bank of America is located in High Springs, not Alachua, this hardship can be eliminated by moving the account. In addition, the Credit Union does not have a plan available to provide interest on checking whereas Bank of America does.

There being no further discussion on the motion a vote was taken. Those present voted unanimously in favor of the motion.

There being no further business the meeting was adjourned.
