AMENDMENT TO ARTICLE III of THE ARTICLES OF INCORPORATION

The Caribbean Philosophical Association is organized exclusively for educational and scientific purposes under Sec. 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, including for such purposes as the making of distributions to organizations that qualify as exempt organizations under Sec. 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

No substantial part of the activities of the Caribbean Philosophical Association shall be the carrying on of propaganda or attempting to influence legislation or participating or intervening in a campaign for political office, either in support of or in opposition to any candidate (including the publication or distribution of statements or other documents).

Notwithstanding any other provision of these Articles of Incorporation, the Caribbean Philosophical Association shall not carry on any activities not permitted for an organization (a) exempt from Federal Income Tax under Sec. 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or (b) eligible for contributions to which are deductible under Sec. 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax code.

Should the Caribbean Philosophical Association members choose to disband, the fiscal assets of the Caribbean Philosophical Association will be distributed to the Centro de Estudios Avanzados de Puerto Rico y el Caribe in Old San Juan, Puerto Rico ("Centro"). Its archives will be declared public domain. If the Centro is no longer in existence or no longer a qualified distributee, then the assts of the Caribbean Philosophical Association shall be distributed to a fund, corporation, or foundation organized and operated exclusively for the purposes specified in Sec. 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.
