The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE 1. - NAME

The name of the corporation shall be FIRST LOVE REVIVAL MINISTRIES, INC.

ARTICLE 2. - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and the mailing address of this corporation shall be 7447 Hawkins Road, Sarasota, FL 34241.

ARTICLE 3. - PURPOSES

The Corporation is formed for the purpose of carrying out a ministry entirely called by God and because of that the first and foremost mandate is that God shall be considered as the foundation of the corporation. 


