Article I
NAME

The name of the corporation shall be the SOUTH FLORIDA ASA, INC.

Article II
PRINCIPAL OFFICE

The principal place of business and mailing address of the SOUTH FLORIDA ASA, INC. shall be the following:

Article III
PURPOSE

The purpose of the SOUTH FLORIDA ASA, INC. shall be: 1) to promote amateur softball for all persons regardless of race, color, creed, religion, sex, national origin or ancestry; 2) to provide it with proper safeguards in accordance with the spirit of true sportsmanship and establish principles for ethical behavior and matters relating to conflict of interest; 3) to promote and conduct, when feasible, amateur softball championships; 4) to educate and train in the proper skills of amateur softball play and rules of the game through promoting, organizing, and conducting clinics, seminars and training courses; and 5) any other lawful acts or activities allowed for under the Florida Not For Profit Corporation Act.

The SOUTH FLORIDA ASA, INC. will conduct its business subordinate to THE AMATEUR SOFTBALL ASSOCIATION OF AMERICA (hereinafter referred to as the ASSOCIATION or ASA, which is also doing business as USA SOFTBALL and AMERICAN SOFTBALL ASSOCIATION), and in accordance with the code and regulations of THE AMATEUR SOFTBALL ASSOCIATION OF AMERICA.


