**ARTICLES OF INCORPORATION
OF
NEIGHBORHOOD MIRACLES, INC.**

The undersigned person, having the age of eighteen (18) years or more, has associated for the purpose of forming a corporation under the laws of the State of Florida, Florida Not for Profit Corporation Act, and does hereby adopt the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of this corporation is: **NEIGHBORHOOD MIRACLES, INC.**

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III
PURPOSE**

The purpose of this corporation is to coordinate and provide dental services to those persons who need dental/restorative treatment and could not otherwise afford the costs associated with said services.

**ARTICLE IV
POWERS**

The corporation may have and exercise any and all rights, privileges and powers which may be held or exercised by corporations not for profit under the "Florida Not For Profit Corporation Act" of the Florida Statutes, as they may be amended from time to time, subject to approval by the session of the **NEIGHBORHOOD MIRACLES, INC.**

ARTICLE V
SUBORDINATION

NEIGHBORHOOD MIRACLES, INC. will be subordinate to JEFF BYNUM DDS, P.A. NEIGHBORHOOD MIRACLES, INC. is a separate and distinct entity from JEFF BYNUM DDS, P.A., and no liabilities of NEIGHBORHOOD MIRACLES, INC. shall fall or pass onto JEFF BYNUM DDS, P.A.

ARTICLE VI
DISSOLUTION

This corporation may be dissolved at any time with the written consent of all the Board of Directors, and approval of the session of NEIGHBORHOOD MIRACLES, INC. On dissolution, the assets of the corporation shall be dedicated to an appropriate municipality, public agency or authority to be used for purposes similar to those for which the corporation is organized. In the event such dedication is not accepted, such assets shall be conveyed or assigned to any nonprofit corporation, association, or other organization devoted to purposes similar to those for which this corporation is organized.

ARTICLE VII
MANNER OF ELECTION

There shall be one (1) member of the Board of Directors, and each member shall serve for a period of three (3) years. The number of directors and the period of the term of the corporation shall be fixed and may be altered from time to time as provided in the bylaws. The method of election of directors is stated in the bylaws.

ARTICLE VIII
INITIAL DIRECTORS

The initial Board of Directors shall consist of one (1) people, who shall serve for three (3) years, and whose names and addresses are:




