CONTINUATION OF ARTICLES OF INCORPORATION (NON-PROFIT)

ARTICLE III PUPOSE

This organization's purpose is to prevent fires and to preserve life and property in the response area of Fire Station #32, as determined by the City of Jacksonville.
The organization shall be chartered under the laws of the State of Florida and function as a department of the City of Jacksonville.

ARTICLE IV MANNER OF ELECTION

All members in good standing shall be given fifteen days advance notice of the date, time and place at which nominations shall be made, and the date, time and place at which elections will be held. Any member in good standing may nominate eligible members for office. The candidate receiving a majority of the votes cast shall be declared elected. If no candidate receives a majority of the votes cast the voting shall continue until there is a majority vote.

The election, which shall be by secret ballot, shall be held during the regularly scheduled business meeting in December.

All elected officers shall serve a term of one year and assume the duties of their office on January 1.
