Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

<u>AMENDMENTS ADOPTED</u>- (OTHER THAN NAME CHANGE)

The following articles are added:

ARTICLE VIII

The Corporation shall have all the powers granted under the Laws of the State of Florida. However, notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in the subsection of Section 501(c) of the Internal Revenue Code of 1965 under which the Corporation chooses to qualify for exception, as the same now exists, or as it may be amended from time to time.

ARTICLE IX

In the event of the dissolution of the Corporation, no Member shall be entitled to any distribution or division of its remaining property or its proceeds, and the balance of all money and other property received by the Corporation from any source, after the payment of all debts and obligations of the Corporation, shall be used or distributed exclusively for purposes within the intendment of Section 501(c) of the Internal Revenue Code as the same now exists or as it may be amended from time to time.
