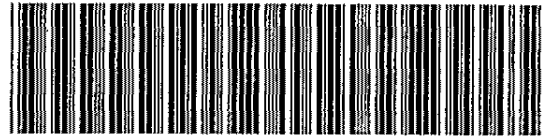

BYLAWS

CHAPTER I – NAME AND OFFICE

Article 1: The name of the corporation shall be: HOA TINH THUONG ASSOCIATION, Inc.

CHAPTER II – POLICIES

Article 1: The Hoa Tinh Thuong Association, Inc. does hereby affirm the adoption of the following principles: Humanity and not for profit.

Article 2: The Hoa Tinh Thuong Association, Inc. is an independent organization; it is not influenced by any individuals, other organizations, religious or political bodies.

CHAPTER III – GOALS AND OBJECTIVES

Article 1: To provide assistance to the disable veterans and/or the families of late soldiers of the Army of the Republic of Vietnam (South Vietnam), who are living in a financially difficult situation in Vietnam.

Article 2: To provide assistance to the children of the above individuals, who need financial support in order to continue their education.

CHAPTER IV – SCOPE OF ACTIVITIES

Article 1: Carry out legal activities governed by the above goals and policies.

Article 2: Fully restrict The Hoa Tinh Thuong Association, Inc. function to non-profit and lawful principles.

Article 3: Cooperate and share information with other non-profit organizations to broaden the quality and quantity of The Hoa Tinh Thuong Association, Inc. activities.

CHAPTER V – MEMBERSHIP

Article 1: Membership requirement:

The Hoa Tinh Thuong Association, Inc. membership will be granted to everyone regardless of sex, race, profession or religion. If under 18 years of age, the applicant must have in writing the consent of their parents or legal guardian.

Article 2: Types of membership (2):

- 2.1 Active Membership
- 2.2 Support Membership

Article 3: Rights and responsibilities:

3.1 Active Members:

- 3.1.1 Submit membership applications to the Hoa Tinh Thuong Association, Inc. and pay annual membership dues.
- 3.1.2 Participate in The Hoa Tinh Thuong Association, Inc. activities.
- 3.1.3 Are entitled to self-nomination. Nomination and voting in The Hoa Tinh Thuong Association, Inc. meetings are under the basis of a majority vote.

3.2 Support members:

- 3.2.1 Support The Hoa Tinh Thuong Association, Inc. spiritually, materially, or financially.
- 3.2.2 Have the right to attend all meetings and/or participate in any The Hoa Tinh Thuong Association, Inc. activities, but do not have the right to vote, to nominate a candidate for office, or to run for an office.

Article 4: Membership dues:

- 4.1 the Executive Committee determines annual membership dues for each active member.

CHAPTER VI – COMMITTEE AND ITS DUTIES

Article 1: Formation of the Executive Committee.

The Executive committee shall consist of the following officers:

- 1.1 The President
- 1.2 The Vice President(s)
- 1.3 The General Secretary
- 1.4 The Treasurer

The officers are elected by the active members during General Meeting.

Article 2: Term of Service:

- 2.1 The Executive Committee shall serve a term of two (2) years. Each current Executive Committee shall be relieved of office in a transfer of responsibility ceremony to the newly elected Executive Committee after serving the two (2) year term.
- 2.2 The President shall call for a committee to prepare for the general election at least three (3) months before the end of the term and the general election will be organized one (1) month before the end of the term.
- 2.3 No member shall be elected President for more than two (2) consecutive terms.

Article 3: Rights and Responsibility:

- 3.1 The President of the Executive Committee shall:
 - 3.1.1 Coordinate and regulate The Hoa Tinh Thuong Association, Inc. affairs.
 - 3.1.2 Represent The Hoa Tinh Thuong Association, Inc. in its public relations with other organizations and associations.
 - 3.1.3 Preside over the meetings of the Executive Committee.
 - 3.1.4 Schedule for meeting(s) for approval of the applications.
- 3.2 The Vice President(s) shall:
 - 3.2.1 Assist the President in the coordination and regulation of internal and external activities of The Hoa Tinh Thuong Association, Inc..
 - 3.2.2 Represent the president in the coordination and regulation of The Hoa Tinh Thuong Association, Inc. affairs in case:
 - a. The President gives his/her proxy.
 - b. The President fails to do his/her duties for personal reasons.
- 3.3 The General Secretary shall:
 - 3.3.1 Keep the documents of The Hoa Tinh Thuong Association, Inc..
 - 3.3.2 Update the administration records of The Hoa Tinh Thuong Association, Inc.:
 - a. list of members
 - b. list of benefactors
 - c. ...
 - 3.3.3 Prepare a schedule for the Executive meetings and the General meetings.
 - 3.3.4 Look over the applications for assistance.
 - 3.3.5 Sign the administrative documents of The Hoa Tinh Thuong Association, Inc..
- 3.4 The Treasurer shall:
 - 3.4.1 Keep and update financial records:
 - a. Bank account
 - b. in charge of sending charity grants to those who meet the criteria
 - c. Report on the financial situation of The Hoa Tinh Thuong Association, Inc. to the General Secretary and during General meetings.
 - 3.4.2 Keep updated records of The Hoa Tinh Thuong Association, Inc. assets.

Article 4: Initial Director and Officers:

- 4.1 President: PHU LE, 5358 FoxBriar Trail, Orlando, FL 32808.
- 4.2 Vice President: HUNG THINH NGUYEN, 5629 Moat CT., Orlando, FL 32810.
- 4.3 General Secretary: TOAN NGUYEN, 1076 Lejay ST., Orlando, FL 32825.
- 4.4 Treasurer: THU LE, 5358 FoxBriar Trail, Orlando, FL 32808.

Article 5: Initial Registered Agent:

CHAPTER VII – SELF-NOMINATION, NOMINATION AND ELECTION

Article 1: The right of self-nomination, or to nominate active members for office of The Hoa Tinh Thuong Association, Inc. is strictly reserved exclusively for active members. Only active members have the right to vote.

Article 2: The members of the Executive Committee shall be elected individually by the majority vote from all active members, including remotely active members.

CHAPTER VIII – RELEASE OF DUTY

Article 1: The President: The President of The Hoa Tinh Thuong Association, Inc. shall be release of duty upon a vote of no confidence rendered by two-thirds (2/3) of the active members in a General meeting. The first Vice President will be the Acting President until the end of the current term.

Article 2: Other Executive Officers: The Hoa Tinh Thuong Association, Inc. President can release other Executive officer(s) from duty with approval from the General meeting by at least 2/3 of Active Members.

CHAPTER IX – AMENDMENT OF BYLAWS

Article 1: Active members shall have the right to propose any amendment to the existing Bylaws.

Article 2: The draft proposal for the amendment should have the approval of more than half of the active members in a general meeting.

Article 3: The new Bylaws shall be sent to all active and support members.

CHAPTER X – DISSOLUTION OF THE HOA TINH THUONG ASSOCIATION, Inc.

Article 1: The Hoa Tinh Thuong Association, Inc. shall be officially dissolved only with at least two thirds (2/3) of all active members present in a special general meeting.

Article 2: In case The Hoa Tinh Thuong Association, Inc. shall be dissociated, all present assets shall be sold in order to raise cash to be sent to benefactors.
