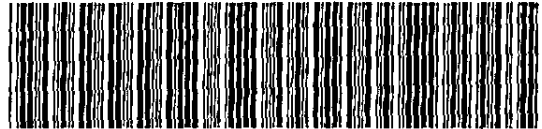

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

**Article 1 - Name**

The name of this corporation is Transfiguration Orthodox Church, Inc.

**Article 2 - Principal Office**

The principal place of business and mailing address office of this corporation shall be:

**Article 3 - Purpose**

The purpose for which this corporation is organized is to establish a Church, faithful to the apostolic tradition, with the Ecumenical Patriarch of Constantinople holding titular or honorary primacy as *primus inter pares* (the first among equals). The unity of the Church is rather manifested in common faith and communion in the sacraments and no one but Christ himself is the real head of the Church. This corporation is organized exclusively for religious purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

#### **Article 4 - Manner of Election**

The initial directors of this non-membership corporation shall be appointed by the incorporator and will elect the directors of the board at the regularly scheduled meeting of the board of directors held on January 1 of each year, as provided for within the bylaws of this corporation.




