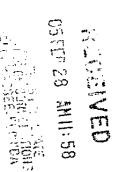

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

3810 DRANE FIELD ROAD WAREHOUSE CONDOMINIUMS ASSOCIATION, INC.
