ARTICLES OF INCORPORATION

The undersigned, being of legal age and competent to contract, for the State of State organizing a not-for-profit corporation pursuant to the laws of the State of Florida, hereby adopts the following Articles of Incorporation, and hereby agrees and certifies as follows:

ARTICLE I NAME

The name of this Corporation shall be SOUTHEAST PARKINSON DISEASE ASSOCIATION, INC.

ARTICLE II PRINCIPAL OFFICE

The address of the principal office and the mailing address of the Corporation shall be P.O. Box 616520, Orlando, Florida 32861-6520.

ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence immediately upon the filing of these Articles of Incorporation with the Florida Department of State, and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV PURPOSES AND GENERAL POWERS

This Corporation, an organization described in Section 509(a)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law, hereafter, the "Code") shall be organized and operated exclusively for charitable, literary and educational purposes within the meaning of Section 501(c)(3).

The specific purposes of this Corporation shall be as follows:

- (i) forming a local chapter of the National Parkinson Foundation;
- (ii) increasing public awareness of Parkinson Disease, its effects on patients and families and the need for public support;
- (iii) providing a centralized online source for medical, legal and financial side for the use and benefit of patients suffering from Parkinson Disease, their caregivers and support groups ("Parkinson Community"), either directly or through other Parkinson Disease related foundations at the national and state levels that are exempt from Federal income tax under Section 501(c)(3) of the Code;

- (iv) furnishing a forum for Parkinson Disease related organizations, associations and groups within the Southeast Region of the United States;
- (v) obtaining 'economies of scale' by combining resources of and uniting Parkinson Disease related organizations, associations and groups within the Southeast Region of the United States, and representing the Southeast Region at meetings and conferences of the National Parkinson Foundation and similar organizations, associations and groups;
 - (vi) fostering patient advocacy and soliciting participation in clinical trials;
- (vii) interfacing with medical personnel, pharmaceutical companies and governmental agencies, and 'fast tracking' potential treatments for and eventually a cure for Parkinson Disease; and
 - (viii) any other activities that are extensions of or in furtherance of the foregoing.

This Corporation shall have all of the powers enumerated in the Florida Not-for-Profit Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted to be carried on by (1) a corporation exempt from Federal Income tax under Section 501(c) (3) of the Code or (2) a corporation, contributions to which are deductible under Section 170(c) (2) of the Code.

ARTICLE V PROHIBITED ACTIVITIES

The Corporation shall not allow any expenditure of any part of the net earnings of the Corporation to inure to the benefit of any member, director or officer of the Corporation, (except that reasonable compensation may be paid for services rendered to or for the Corporation effecting one or more of its purposes), nor shall any member, director or officer of the Corporation, or any private individual, be entitled to share in the distribution of any of the Corporation's assets on dissolution of the Corporation, or shall a substantial part of the activities of the Corporation be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene (including the publication and distribution of statements) in the political campaign on behalf of any candidate for public office.

ARTICLE VI MEMBERSHIP

The members of this not for profit Corporation, if any, shall be qualified and admitted as set forth in the Bylaws of this Corporation.

ARTICLE VII INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Corporation shall be located at 1000 Legion Place, Suite 1700, Orlando, Florida 32801, and the initial registered agent of the Corporation at that address shall be W. Charles Shuffield, Esquire. The Corporation may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Incorporation.

ARTICLE VIII INITIAL BOARD OF DIRECTORS

The Board of Directors shall be appointed and their number either increased or diminished from time to time as provided in the Bylaws, provided that there should not be less than three (3) Directors. Directors may be removed with or without cause. The names and addresses of the initial Directors are as follows:

ARTICLE X BYLAWS

Except as otherwise provided by law, the power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Trustees.

ARTICLE XI INDEMNIFICATION

In addition to any rights and duties under applicable law, the Corporation shall indemnify and hold harmless all its Trustees, officers, employees and agents, and former Trustees, officers, employees and agents from and against all liabilities and obligations, including attorneys' fees, incurred in connection with any actions taken or failed to be taken by said Trustees, officers, employees and agents in their capacity as such to the fullest extent permitted under applicable law.

ARTICLE XII AMENDMENTS

The Board of Trustees reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto.

ARTICLE XIII HEADINGS AND CAPTIONS

The headings or captions of these various Articles are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.

ARTICLE XIV DISSOLUTION ACTIVITIES

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provision for the payment of all the liabilities of the Corporation, transfer all of the assets of the Corporation such organization or organizations as being exempt from federal income tax under Section 501(c)(3) of the Code. Any such assets not so disposed of shall instead be disposed of by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for charitable, educational, religious, or scientific purposes, and which qualify as an exempt organization or organizations under Section 501(c) (3) of the Code.
