

# Amended Articles of Incorporation

#### ARTICLE I – NAME

The name of this organization shall be the "Winter Springs Police Association, Inc."

#### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III – PURPOSE

The Winter Springs Police Association, Inc. is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This organization shall encourage and direct social and civic activities of its members. This shall include raising money to assist members of our community as well as families of Public Servants who are in need.

#### ARTICLE IV – DISTRIBUTION OF EARNINGS

No part of the net earnings of the Winter Springs Police Association, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of

the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### ARTICLE V – DISSOLUTION OF ASSOCIATION

Upon the dissolution of the Winter Springs Police Association, Inc. any assets shall be distributed equally to, up to three (3) valid 501 (c) (3) organizations voted upon by the members.
