ARTICLES OF INCORPORATION OF SIKH DHARMA OF CENTRAL FLORIDA, INC.

Pursuant to the provisions of Section 617, Florida Statutes, the undersigned Incorporators hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation shall be SIKH DHARMA OF CENTRAL FLORIDA, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business of this Corporation shall be 400 Center Street, Altamonte Springs, FL 32701, and the mailing address shall be the same.

ARTICLE III - PURPOSE

The specific and primary purpose for which this corporation is formed is to operate for the advancement of the Sikh religion by the distribution of its funds for such purposes, by providing the organizational framework for the teaching and practice of the Sikh Way of Life in this state and including, but not limited to, the creation and operation of educational centers and associated and supportive activities and any other act or thing attendant to the operation of an educational, religious organization which is not otherwise limited by law or these Articles.

The general purposes for which this corporation is formed are to operate as a church for religious purposes, including the doing of any and all acts and things that a non-profit corporation is empowered to do, which may be necessary, convenient or desirable in the administration of the general purposes of this corporation and including the power to contract, rent, buy, or sell personal or real property.

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3).

ARTICLE IV - MANNER OF APPOINTMENT

The directors shall be appointed as provided in the By-Laws:

There shall be a Board of Directors for this Corporation, which shall consist of not less than three (3) persons.

ARTICLE V - INITIAL DIRECTORS

The names and street addresses of the persons who shall serve as Directors of the Corporation, who, subject to these Articles of Incorporation and the laws of the State of Florida,

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its Members, Trustees, Officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article III hereof. substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding Sections of any future federal tax code, or (b) by a Corporation. contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding Section of any future federal tax code.

ARTICLE X - DISSOLUTION DESIGNATIONS

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding Section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
