ARTICLES OF INCORPORATION

OF

JOSIE'S PASSOVER AND GOOD FRIDAY SERVICE, INC.

The undersigned, Incorporation for the purpose of forming a **Not for Profit**Corporation under the Florida Business Corporation Act, Chapter 617.0202 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE 1: NAME OF THE CORPORATION
