Articles of Incorporation Holden Heights Community Development Corporation

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Law Florida, do hereby certify:

Article I

The name of the Corporation shall be Holden Heights Community Development Corporation.

Article II

The place in this state where the principal office of the corporation is to be located is 1224 26th Street in Orange County.

Article III

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV

The name and address of the persons who are the initial trustees of the corporation are as follows:

L.C. Bradley, 2631 Marquise Ct., Orlando, Fl 32805 – President Rhonda Stapleton, 1219 22nd Street, Orlando, Fl 32805 – Vice-President Rudolph Bright, 1516 East Halicrest Street # 304, Orlando, Fl 32803 – Treasurer Sheila Bass, 2403 Shortleaf Ct., Orlando, Fl 32818 – Secretary

Article V

The business affairs of this corporation shall be managed by a Board of Directors, which shall consist of not more than 10 and not less than 5 directors.

The members of the Board of Directors shall be elected by a majority vote of the voting members of the corporation at the annual meeting of the members in January, upon the recommendation of the Nominating Committee and the President.

With the exception of the initial Board of Directors, the term of office of a director shall be three years. Each director shall take office immediately after the regular meeting of the Board of Directors at which time they were elected and shall hold office until his/her term expires. A director may resign at any time and the portion of the term remaining shall be filled by a person elected by a majority vote of the remaining directors at a regular meeting of the Board.

A person who is over the age of 18, and who is a resident of the corporation's service community, as specified by Holden Heights Community Development Corporation, is qualified to serve as a director of the corporation. Further, any director who becomes a paid employee of the corporation must immediately resign as a director.

Article VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501© (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
