The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following articles of incorporation:

**ARTICLE I - NAME**

The name of the not-for-profit corporation is TNT Misfits, Inc.

**ARTICLE II - DURATION**

The corporation shall have perpetual existence commencing on the date of filing.

**ARTICLE III - PURPOSE**

The corporation is organized and may engage in any activity, business or purpose not-for-pecuniary profit permitted under the laws of the United States and the State of Florida and under the laws of any other State or other country in the world not inconsistent with Chapter 617 Florida Statute. This corporation purpose includes but is not limited to event planning, costume preparation, organizing, participating and promoting cultural events including but not limited to Miami Carnival.

**ARTICLE IV - INITIAL REGISTERED AGENT**

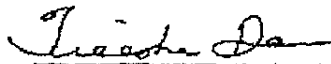
