TO

ARTICLES OF INCORPORATION

HIGHLANDS RESERVE OF PALM CITY HOMEOWNERS' ASSOCIATION, INC. 8/6

The Articles of Incorporation of Highlands Reserve of Palm City Homeowners' Association, Inc. were filed with the Florida Secretary of State on January 21, 2005. The same Articles of Incorporation are hereby amended as approved by a vote of at least 51 % of the Members attending, in person or by proxy, the Members Meeting held on October 30, 2014.

1. The Ninth and Tenth Articles are amended to read as follows:

Ninth:

Annual meetings of the members shall be held on a date and time determined by the Board of Directors. After each annual meeting of the Members, the Directors shall elect officers of the Corporation who will hold office until their successors are elected and qualified.

Tenth:
