OF
INCORPORATION**

SOUTH FLORIDA REUSE AND RECYCLING INSTITUTE INC.

ARTICLE 1

NAME

The name of the corporation is South Florida Reuse and Recycling Institute Inc. It is a not-for-profit corporation constituted and established under the laws of the State of Florida.

ARTICLE 2

PRINCIPAL OFFICE

The initial principal office of the Corporation shall be located at:

ARTICLE 3

PURPOSE

The Corporation is organized exclusively for educational, charitable, and scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt status under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Corporation has the purpose of providing the following services to educators, families, the arts community and the business community:

- Resource Center(s) offering free or inexpensive materials for the creation of instructional materials or creative arts projects;
- Workshops that provide comprehensive training in maximizing the use of re-usable and recyclable materials for developing interdisciplinary classroom tools and creative re-use craft projects;

- Workshops for parents, children and the general public teaching environmental responsibility through re-use and recycling;
- Programs to raise awareness regarding waste and its inherent environmental and economic costs to our local community, and the promotion of waste minimizing re-use and recycling methods and alternatives;
- Programs to promote businesses' environmental responsibility and stewardship by helping businesses reduce waste and waste disposal costs by diverting portions of their disposal stream through re-use and recycling;

The Corporation is irrevocably dedicated to and operated exclusively for non-profit purposes.

ARTICLE 4

MANNER OF ELECTION

The appointment of any members to the Board of Directors will be the result of a vote by the majority of the Board of Directors constituting a quorum at the time of the election.

Permanent Positions

In recognition of the purpose of the Corporation, the members of the Board elected to these positions shall have the sufficient background and experience, as determined by the Board, to provide insight and leadership that is commensurate with the mission of the Corporation as defined below.

Three (3) members will have sufficient background experience in the fields of child education/ child development, management of non-profit organizations, marketing, community arts and culture or any other related experience that the Board finds appropriate.

Three (3) members will have sufficient background experience in the fields of solid waste, recycling, waste minimization, creative re-use, or any other related experience that the Board finds appropriate.

One (1) member shall be elected for an at-large position. This person may qualify for a position as described above or may bring other benefits to the Corporation.

The qualifications of additional Board members may be at qualifications that the Board at the time determines to be in the best interest of the Corporation.

Annually Renewable Positions

From time to time the Board of Directors may find it in the best of interest of the Corporation to add positions to the Board of Directors. The positions will be for a term of one year beginning on the first day of the month following the appointment and ending on the final day of the 12th month. Renewing these positions must be done by a majority of the Board of Directors representing a quorum prior to the expiration of the position.

ARTICLE 9

POLITICAL/OTHER ACTIVITIES

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and this corporation shall not participate in, or on behalf of, or in opposition to, any candidate for public office.

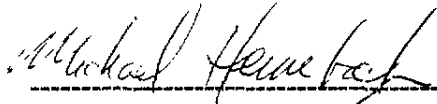
Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170(c) (2) or the Internal Revenue Code.

ARTICLE 10

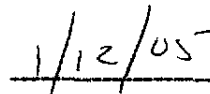
DISSOLUTION

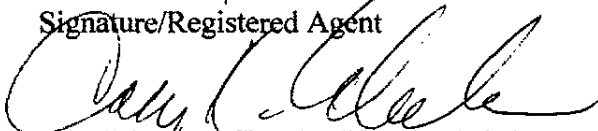

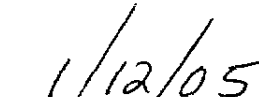
