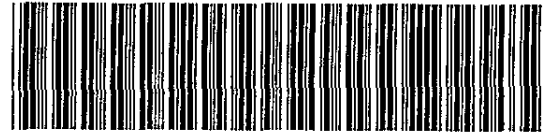

The undersigned, acting as incorporators of a corporation pursuant to chapter 617.0202 of Florida Statutes

ARTICLE I: NAME

The name of the Corporation shall be:

Bay Area AIDS Network, Inc.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. Bay Area AIDS Network, Inc. is a not-for-profit corporation organized within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision or any future United States Internal Revenue Law is exclusively charitable, literary, and educational. The specific purpose of the corporation is to provide services to persons in need with food, shelter, clothing, healthcare and education/information. Bay Area AIDS Network, Inc. serves as a vehicle to address the basic needs for survival of the disenfranchise.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
