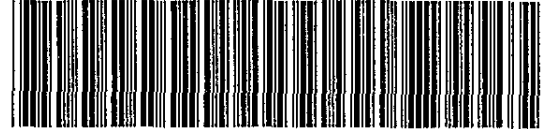

**ARTICLES OF INCORPORATION
for
GATEWAYS TO RECOVERY INC.
A Florida Not for Profit Corporation**

ARTICLE I – NAME

The name of this corporation shall be Gateways to Recovery Inc.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III – PURPOSE

This corporation is organized and operating for charitable and education purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as subsequently amended. Specifically, the Corporation's purpose is for the development and application of educational, recreational and general support services for those individuals, families, friends and the community-at-large affected by the disease of substance addiction and abuse.

ARTICLE IV – MANNER OF ELECTION

The powers of this Corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors, consisting of not less than 7 persons. The number of Directors of the Corporation shall be 7 provided, however, that such number may be changed by a by-law duly adopted by the members.

The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of Directors shall be held.

Directors elected at the first annual meeting, and at all times thereafter, shall serve for a term on one (1) year until the annual meeting of members following the election of Directors, except for the Director/Treasurer who shall serve for a two (2) year term and, until the qualification of the successors in office. Annual meetings shall be held in January of each year at such place or places as the Board of Directors may designate from time to time by resolution.

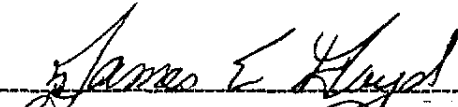

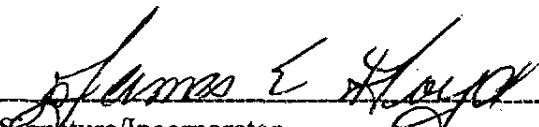
