

ARTICLES OF INCORPORATION for GATEWAYS TO RECOVERY INC. A Florida Not for Profit Corporation

ARTICLE I - NAME

The name of this corporation shall be Gateways to Recovery Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: James Boyd 3704 Malec Circle Sarasota FL 34233

ARTICLE III - PURPOSE

This corporation is organized and operating for charitable and education purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as subsequently amended. Specifically, the Corporation's purpose is for the development and application of educational, recreational and general support services for those individuals, families, friends and the community-at-large affected by the disease of substance addiction and abuse.

ARTICLE IV – MANNER OF ELECTION
