ARTICLES OF INCORPORATION

OF

ARTICLE I NAME

The name of the not-for-profit corporation is International Energy Advisory Council, Inc. (the "Corporation").

ARTICLE II ADDRESS

ARTICLE III REGISTERED AGENT AND OFFICE

ARTICLE IV PURPOSE, POWERS AND RIGHTS

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to (i) provide the services of an energy trade association, and (ii) engage in any lawful act or activity for which corporations may be organized under the Florida Not For Profit Corporation Act (the "Act").

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Act.

ARTICLE V DIRECTORS

Members of the Board of Directors shall be elected as provided in the Bylaws of the Corporation. The number of members of the Board of Directors may be increased or diminished from time to time as provided by the Bylaws; provided, however, there shall never be less than three.
