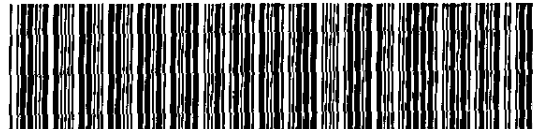

ARTICLE III- PURPOSES

TO ADD THE FOLLOWING INFORMATION:

1. THE PURPOSE OF IGLESIA DE RESTAURACION ELOHIM, INC. IS TO SHARE AND PROCLAIM THE GOSPEL OF JESUS CHRIST BY IMPLEMENTING SEVERAL STRATEGIES AND METHODS INCLUDING, BUT NOT LIMITED TO, THE PREACHING OF THE GOSPEL, EVANGELISM, BIBLICAL DISCIPLESHIP, WORSHIP , COUNSELING AND ANY OTHER MEANS WHICH WILL HELP THE INDIVIDUAL TO DEVELOP SPIRITUAL, SOCIAL AND MORAL VALUES.

2. THE INSTITUTION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND/OR SCIENTIFIC PURPOSES UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE.

3. NO PART OF THE NET EARNINGS OF THE ORGANIZATION SHALL INURE TO THE BENEFIT OF, OR TO BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE ORGANIZATIONS SHALL BE AUTHORIZED AND

EMPOWERED TO PAY REASONABLE COMPENSATIONS FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSE SET FORTH IN THE PURPOSE CLAUSE HEREOF. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE ORGANIZATION SHALL BE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE ORGANIZATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.

NOTWITHSTANDING ANY OTHER PROVISION OF THIS DOCUMENT, THE ORGANIZATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED OUT ON (a) ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE OR (b) SECTION 170 (c) (2) OF THE INTERNAL REVENUE CODE (OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE)..

4. UPON THE DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANINGS OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.
