ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

The Name of the Corporation shall be:

Darby Estates Homeowner's Association, Inc.

Article II – Principal Office

Article VIII - Management of Common Property

The Corporation shall have the power to own and convey property. The Corporation shall also have the power to operate ands maintain the common property, specifically the surface water management system facilities including all inlets, ditches, swales, culverts, water control structure, retention, and detention areas, ponds, lakes, flood plain compensation area, wetlands and any associated buffer areas, and wetland mitigation areas. The Corporation shall also have the following specified powers:

- A. Establish rules and regulations concerning common property,
- B. Assess members of the Association and enforce said assessments,
