Article III Part (A). No substantial part of the activities of P.W.A., Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and P.W.A., Inc. shall not participate in, or intervene in (including the publishing and distribution of statements) of any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, P.W.A., Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or in the corresponding section of any future federal tax code, or (b) by a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Part (B) Dissolution. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes
