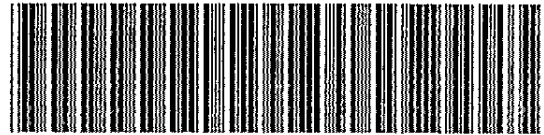

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is organized exclusively for charitable and educational purposes to exist in perpetuity unless dissolved. If dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as a tax exempt, charitable organization under the provisions of 501 (c)(3) of the Internal Revenue Code or corresponding section of any future tax code. No proceeds of this corporation shall be used to enrich any individual, with the exception of salaries paid to full time and/or part time employees for services to the corporation.

This corporation is a dedicated organization, founded by educators, with the intent to provide educational tutoring and psychological testing, to children of low-income families. We will achieve our mission by increasing individual standardized test scores and providing evaluations to identify children that would qualify for Exceptional Student Education. Our organization will also educate parents on Florida's state educational laws, to appropriately meet their child's individual needs.


