The undersigned subscribers to these Articles of Incorporation, desiring to form a notfor-profit corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

Article I. Corporate Name

The name(s) of this Corporation shall be:

S.O.W. Strangers, Orphans & Widows Community Association, Inc.

Article II. Terms of Existence

This corporation shall have perpetual existence

Article III. Purposes and Powers

Said corporation is organized exclusively for charitable, and educational purposes, including programs and projects that will include, but not be limited to workshops, lectures and seminars that will encourage participants into a life of self sufficiency.
